

Mad Money

To be held in conjunction with the Paint Horse Congress October 18-22, 2023 in Oklahoma City, Oklahoma.

The Mad Money Yearling Halter Futurity is open to Yearling Mares, Stallions, and Geldings and **open to all recognized stock breed associations. We will offer six classes:**

Non-Pro Yearling Mares

Non-Pro Yearling Stallions

Non-Pro Yearling Geldings

Yearling Mares

Yearling Stallions

Yearling Geldings

Each class will have a \$25,000 purse and every horse that shows will receive a payout.

RULES:

- **All horses must have registration papers with a recognized breed association (AQHA, APHA, ApHC, PHBA, IBHA, ABRA, PtHA, ARHA).**
- **All horses will complete an entry form and provide all required documentation to include: registration papers, entry fee payment in full, completed W-9 form, and copy of Youth/Amateur/Non-Pro Card if applicable.**
- **All horses must have a current health paper and Coggins.**
- **Horse leases are not allowed.**

- **Exhibitors showing in a Non-Pro class must meet relationship requirements and have a current Youth/Amateur/Non-Pro Card in the respective breed association.**
- **A Youth Exhibitor may not show a Yearling Stallion in Non-Pro Yearling Stallions or Yearling Stallion Classes.**
- **Entry fees are \$250 per class and an office charge of \$25.**
- **The highest placing APHA Horse in each class will receive a cash bonus. APHA registered yearlings are encouraged to participate in the corresponding APHA class at the Paint Horse Congress.**
- **Entry deadline is 5:00 pm CST of the day prior to when the class shows.**
- **Unsportsmanlike conduct or any other form of misconduct that is irresponsible, illegal, indecent, profane, intimidating, threatening or abusive is prohibited by any person on the show grounds.**
- **No person on the show grounds may treat a horse in an inhumane manner.**
- **Lip chains and lip cords are acceptable.**
- **All entries will jog to the judges and continue to jog around the corner cone to the left and to the end marker. Failure to adequately evaluate the gait will be left to the judge's discretion. All horses will be lined up at the discretion of the ring steward.**
- **Entries will enter the arena by age. Beginning with youngest of that calendar year to the oldest.**
- **Exhibitors unable to track their horse may have a substitute handler. Youth/Amateur/Non-Pro exhibitors must have another Youth/Amateur/Non-Pro with a current Youth/Amateur/Non-Pro Card as a substitute handler. This substitute handler may lead the horse through the tracking portion of the class and into the lineup. The exhibitor must set up and present the horse for the remainder of the class. The substitute handler shall remain in the arena for the duration of the class at a safe and reasonable distance. In the event of a disruption, the handler may assist, however they may not coach or provide any other assistance.**
- **Stallions and mares will be mouthed.**
- **An open leg wound may be covered by a bandage not to exceed 1 and ½ wraps of vet wrap or similar material and not over 4 inches in width.**
- **Horses will only be excused at the discretion of Show Officials.**

- **Finalist payouts will be given to horses placing after 10th place.**
- **Any horse that is excused will receive a finalist payout.**
- **No cell phone usage or texting in the arena.**
- **There will be no fraternization between an exhibitor and a judge during the show.**
- **The judges' decision is final. Once the judges have marked their cards and awards have been made, there shall be no changes.**
- **Neither the Judge nor any member of his/her family shall exhibit or act as agents, representatives in any capacity of any horse he or she is officiating at the 2023 Mad Money Yearling Halter Futurity.**
- **A judge shall not judge a horse which is owned or exhibited by anyone from who he/she or member of his/her immediate family have been paid or received a salary, commission or any type of remuneration or consideration, directly or indirectly, within 60 days of the date of the first class of the futurity. Exception: Farrier fees, breeding fees, mare care, vet expenses, shipping fees or any other fees related to breeding.**
- **Judges are allowed on the show grounds only when serving in an official capacity. Judges' family members are not allowed on the show grounds at any time during the show.**
- **No excessive verbal professional coaching.**
